CODE OF CONDUCT FOR ALL CADETS AND THEIR GUEST

- 1. Cadets will, at all times, be responsible for the conduct and behaviour of their guest. If at any time the squadron staff deems the conduct of a guest to be inappropriate or contrary to the Squadron Standing Orders their parent/guardian will be contacted, and they will be asked to leave without further justification.
- 2. All cadets and guests who plan to attend the dance must arrive by 8:00PM. No one will be permitted to enter the dance after the close of admission, unless arrangements are made in advance with the Commanding Officer.
- 3. The Canadian Cadet Organization has a zero-tolerance policy on drugs and alcohol. Any cadets or their cadets found to be in possession of these substances or having recently consumed these substances will have their parent/guardian contacted and will be asked to leave the premises.
- 4. Cadets and their guest must enter the dance at the same time. An individual who is not a cadet at 5 Cyclone Squadron will not be admitted to the dance alone.
- 5. Cadets and guests are expected to obey all squadron rules under penalty of consequences as listed in the Squadron Standing Orders.
- 6. In the event of an emergency, the guest student's parent or guardian will be contacted. When immediate medical attention seems essential, 5 Cyclone Air Cadet Squadron personnel will contact emergency medical services to transport the child to an appropriate medical facility by ambulance.

Failure to adhere to the above-noted code of conduct, at any point during the dance, could result in both the cadet and guest having their parent/guardian contacted and being asked to leave the premises without further justification.
